Full part loans are £195pcm plus fully inclusive – Shared loans are £100pcm

Should you wish to cancel the loan one months paid notice must be given.

Wapley stables may cancel the loan at anytime without notice.

You must still have a minimum of one paid riding lesson per month with our instructor to ensure correct skills are maintained.

**You will need to provide your own personal and public liability insurance to a minimum of £2,000,000, evidence of this insurance must be produced to Wapley Stables prior to commencement of this loan.**

You may use the pony on a non riding school day which at present is Tue, Thur, Sun, one of these days you must rest the pony, and one other day you may jump to a maximum of 85cm/2'9". Ponies may only be ridden for a Maximum of 1 hour each day.

You are responsible for the care of the pony on these days. Please advise if you are going on holiday on unable to attend.

One Sunday afternoon each month the horse may be used by LH Academy – In this event you may ride in the morning.

**If you are on a shared loan agreement please confirm your days and times with Lucy**

**YARD RULES**

1. Hats must be worn and comply with the latest standards when mounted and leading to and from fields. Should you receive a different riding hat please advise Lucy to check and document standard compliance
2. Any items left at the stables are done so at your own risk, Wapley Stables accept no responsibility for lost items
3. Any children entering the premises are the responsibility of their parent/guardian, maximum of two people to accompany loaner. Wapley Stables accept no responsibility for injuries caused. Please remember Livery yards are a dangerous place and animals are unpredictable.
4. Under no circumstances are children under the age of 16 years to be left unsupervised on the yard. The only exception being is If aged 14 or 15 years Lucy has assessed them as being competent and signed document
5. For Health and Safety and Fire regulations this stable yard is a No Smoking yard.
6. No dogs or pets are to be brought onto the premises.
7. The yard is open between 8am - 9pm Mon to Sun. The last person to leave the yard is responsible for ensuring that everything is locked up, alarm is activated and lights turned off.
8. The water is on a meter and therefore please use the water thoughtfully.
9. All Loaners are responsible for the full care of the horse/pony on Christmas Day, Boxing Day and New Years day.
10. The stables, tack room, yard and facilities are to be kept clean and tidy at all times.  
All droppings must be cleared from ménage and horse walker after use and other areas.
11. Stables must be mucked out and left clean.
12. Tack must be cared for and ensure all items covered and put away after use
13. Please respect the facilities by ensuring all cutlery and crockery used is washed and cleared away
14. Only the loaner is permitted to ride the pony and no one else
15. No more than three mounted riders to use the arena at one time.
16. Vet bills are excluded from this agreement where the pony has been injured (with new injury) whilst you are riding or through your negligence
17. You will need to provide your own personal and public liability insurance to a minimum of £2,000,000, evidence of this insurance must be produced to Wapley Stables prior to commencement of this loan.
